

## CONTENT CONTRIBUTION AGREEMENT

This Agreement is made between HonestlyNow.com ("HonestlyNow.com") and \_\_\_\_\_ ("Contributor").

### RECITALS

- A. HonestlyNow.com edits, publishes and may distribute content related locations of post offices in the United States.
- B. HonestlyNow.com intends to award one or more scholarships.

Now, therefore, the parties agree as follows:

2. The Contributor shall indemnify and hold HonestlyNow.com harmless from any claims regarding the Contribution.

3. The Contribution shall become the property of HonestlyNow.com upon submission.

Contributor does hereby sell, assign, and transfer to HonestlyNow.com, its successors and assigns, the entire right, title and interest in and to the copyright in the Contribution and any registrations and copyright applications incorporating the Contribution, including any renewals and extensions, and in and to all works based upon, derived from, or incorporating the Contribution, and in and to all income, royalties, damages, claims and payments now or later due or payable, and in and to all causes of action, either in law or in equity, for past, present, or future infringement, and in and to all rights corresponding to the foregoing throughout the world.

4. HonestlyNow.com shall have the right to use, exhibit, and distribute the Contributor's name, likeness, image, voice, video, and biographical information for any promotional or business purposes and in any medium which HonestlyNow.com deems appropriate.
5. HonestlyNow.com, in its sole discretion, will decide whether to register copyright for the Contribution in its own name and at its own expense.
6. Contributor shall receive no financial remuneration for the Contribution. The amount, timing, and number of any scholarships awarded shall be in HonestlyNow.com's sole discretion.
7. This constitutes the entire agreement between HonestlyNow.com and the Contributor and supersedes any other understandings or agreements.
8. Contribution does not contact or rely upon and intellectual property or trade secrets or other nonpublic technical details or business information of any kind of a third party.
